The Board of the County Commissioners in and for Garden County, Nebraska, met on August 25, 2025 at the Garden County Courthouse for their regular meeting, pursuant to statute. Notice of the regular meeting was given in advance by publication in the Garden County News on August 20, 2025. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Chairman Dymak called the meeting to order at 8:30 a.m. with the following members present: Terry Krauter, David Dymak, Dixann Krajewski.

Dymak acknowledged that the Open Meeting Laws are posted on the meeting room wall along with the Garden County Board Meeting Guidelines. Pledge of Allegiance was said.

Motion was made by Dymak, seconded by Krauter, to approve the consent agenda, which includes Agenda, Minutes of last regular meeting and Board of Equalization held August 11, 2025, claims and payroll by general consent and allow the County Clerk to issue warrants in payment of the claims and payroll (The \$19,651.84 check to Five Nines will be held pending approval at the next meeting for payment out of the Tribal Funds – LATCF Fund 2585). Frerichs gave the Road Report and updated the Board on the Lisco Bridge project.

Motion was made by Dymak, seconded by Krajewski to approve the Inventories submitted by Officials and Department Heads. Roll call vote: Yeas: Krauter, Krajewski, Dymak. Nays: 0. Motion carried.

Motion was made by Krauter, seconded by Dymak to approve Resolution 2025-8-3 to approve the County Annual Certification of Program Compliance to Nebraska Board of Public Roads Classifications and Standards. Roll call vote: Yeas: Dymak, Krajewski, Krauter. Nays: 0. Motion carried

Motion was made by Dymak, seconded by Krajewski to approve the increase in salary for Gerald Frerichs at \$2,417.90 per pay period to begin effective immediately. Roll call vote: Yeas: Krauter, Krajewski, Dymak. Nays: 0. Motion carried.

Dymak adjourned the meeting at 10:35 a.m.
