The Board of the County Commissioners in and for Garden County, Nebraska, met on November 24, 2025 at the Garden County Courthouse for their regular meeting, pursuant to statute. Notice of the regular meeting and Board of Equalization were given in advance by publication in the Garden County News on November 19, 2025. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Chairman Dymak called the meeting to order at 8:30 a.m. with the following members present: David Dymak and Terry Krauter. Dixann Krajewski was absent.

Dymak acknowledged that the Open Meeting Laws are posted on the meeting room wall along with the Garden County Board Meeting Guidelines. Pledge of Allegiance was said.

Motion was made by Dymak, seconded by Krauter, to approve the consent agenda, which includes Agenda, Minutes of last regular meeting and Board of Equalization held November 10, 2025, claims and payroll by general consent and allow the County Clerk to issue warrants in payment of the claims and payroll. A copy of which is on file in the office of the County Clerk. Roll call vote: Yeas: Dymak, Krauter. Nays: 0. Motion carried.

Public Comment: Karin Lane gave an update on a building issue.

Ross gave the Sheriff Report.

Leach gave the Transportation Report.

Frerichs gave the Road Report. There was an update on the studies required for the Lisco Bridge.

Salary Resolution discussion was held.

The Lab Agreement was discussed.

Motion was made by Krauter, seconded by Dymak to approve Resolution 2025-11-5 to take the Sheriff's body and car camera expense from Inheritance Tax Fund with repayment over the next four years. Roll call vote: Yeas: Krauter, Dymak. Nays: 0. Motion carried.

Motion was made by Krauter, seconded by Dymak to approve Resolution 2025-11-4 the Year End Certification of County Highway Superintendent (Anthony Krajewski). Roll call vote: Yeas: Dymak, Krauter. Nays: 0. Motion carried.

Lisco Bridge weight limit discussion was held.

Motion was made by Dymak, seconded by Krauter to approve the Waiver of Minor Subdivision for Todd and Linda Terry. Roll call vote: Yeas: Krauter, Dymak. Nays: 0. Motion carried.

Motion was made by Krauter, seconded by Dymak to approve the Agreement between the Administrative Office of the Court and Garden County for Ex Officio Clerk of the District Court. Roll call vote: Yeas: Dymak, Krauter. Nays: 0. Motion carried.

The 2026 Holiday Calendar was tabled until the next meeting.

Applications for Keno Funds will not be taken this year due to limited funds available.

Terry Jessen discussed dangerous ditches and unsafe road conditions. He requested a ride along with a Board Member and/or Road Superintendent and requested roads be returned to the way they were in previous years without deep ditches. He also requested that the board draft a letter indicating that no more ditches would be installed.

Dymak adjourned the meeting at 10:02 a.m.
